II. Breeding Options:

A: Fresh Cooled Shipped Semen Fees:

Collection Fee: \$350 per collection, must be paid in advance. (Price is direct charge from breeding station and may fluctuate with season or station fees)

Shipping Fee: \$100 - \$300 for domestic US shipping FedEx/UPS/DHL. Counter to Counter, same day airline shipping is available 7 days a week and on holidays. Pricing will vary depending on destination location and could be less but should not exceed the amounts stated. Repro Vet requires 24 hours' notice on the shipment of semen. Contact 425-518-1588 to arrange for semen shipment.

Payment options: Payment can be made electronically through Zelle using my phone # for account, Venmo to @pamela-mcmahon-3 or direct mailed to my home address for either or both the deposit and the balance.

B: On-Site Breeding:

You may have your mare bred onsite at the breeding facility located in Arlington WA. Ultrasound, insemination, and mare care fees will apply.

Mare Care: Mare care is to be paid for in advance and any additional fees incurred must be paid prior to the mare leaving the breeding facility. The mare will not be released until all mare care fees have been paid in full. Mare w/foal at side - **\$35.00/per day** or \$800 per month or Mare alone - **\$25/per day or \$750 per month.**

III. Veterinary & Farrier Services for on-site breeding

In the event of an emergency, permission is hereby granted to Pamela McMahon, the breeding facility owners, or caretakers, to call a veterinarian or farrier. All subsequent fees incurred by your mare or mare/foal are to be paid immediately by the mare owner(s) upon presentation of said expense. Mare owner(s) will be notified as soon as possible if an emergency of any kind arises. **The mare must be current on**

vaccinations as well as her worming, with the documentation of such to be presented prior to or upon the mare's arrival.

IV. Live foal Guarantees

We grant a live 30-day foal guarantee. If your mare produces a foal which does not stand to nurse and live healthy for a full 30 days, upon request we will issue a “Re-Breeding Contract” and you are entitled to re-breed your mare under the terms of the Re-Breeding Contract. If said mare is deemed “not sound for breeding” by a veterinarian, an approved substitute mare may be utilized. Champ has been DNA tested CLEAR PSSM1. Champ has been tested HOMOZYGOUS for black, We WILL assist you in registering your foal with the appropriate registry/registries.

V. Liability for on-site breeding

All reasonable efforts will be made to provide your mare or mare/foal with proper care to insure their health and safety. However, neither Pamela McMahan, the breeding facility owners, nor the caretakers shall be held liable for any loss, sickness, disease, or injury sustained during the time they are in the care of Pamela McMahan and/or the breeding facility. If a stallion should become sterile or incapable of breeding for any reason, or sold, Pamela McMahan has the right to offer a substitute stallion owned by Pamela McMahan to the mare owner. Mare owner may choose any stallion owned by Pamela at that time. This contract expires within 1 year of the date of the contract.
